Dues Classes

Membership in the NCITD is open to anyone with an interest in import and export. Companies with professional interests in these areas are strongly encouraged to join. Because members of the press do not engage in international trade, or the facilitation of international trade, the meetings will not be open to the press. Annual dues are assessed based on company size with a separate scale applying to service providers.
